<b>Name</b>	Running Deer (BSR Complex)
<b>Description</b>	<p><b>Type:</b> Gallery Range</p> <p><b>Danger area:</b> Full Danger Area (FDA)</p> <p><b>Location</b> (What3words): Chip.pans.slower</p> <p><b>Distance:</b> 7m - 100m</p> <p><b>Targets:</b></p> <ul style="list-style-type: none"> <li>• 20 turning targets (4x banks of 5)</li> <li>• Moving target</li> </ul> <p><b>Additional notes:</b> There is open access to other ranges within the BSR complex (see coordinating instructions below)</p>
<b>FIREARMS AND AMMUNITION</b>	
<b>Permitted firearms and ammunition including ME &amp; MV</b>	<p><b>Type:</b> .Rifles; gallery rifles and pistols by special arrangement only</p> <ul style="list-style-type: none"> <li>• <b>Maximum Muzzle Velocity:</b> 1000 m/s (3280 ft/s)</li> <li>• <b>Maximum Muzzle Energy:</b> 4500 J (3319 ft/lb)</li> <li>• <b>HME Permitted:</b> 4500J – 7000J HME procedures apply</li> </ul> <p><b>Type:</b> Shotguns</p> <ul style="list-style-type: none"> <li>• Solid slug only up to a maximum of 10 bore with prior approval of the BSR manager</li> <li>• Not permitted for use on the moving target</li> </ul> <p><b>Not Permitted:</b></p> <ul style="list-style-type: none"> <li>• .22 Hornet</li> <li>• .22-250</li> <li>• .220 Swift</li> <li>• No muzzle brakes to be used inside the hut at 100m</li> </ul>
<b>RANGE SAFETY LIMITATIONS</b>	
<b>Coordinating Instructions</b>	<ol style="list-style-type: none"> <li>Shooting on this range affects the following ranges: <ol style="list-style-type: none"> <li>BSR <ol style="list-style-type: none"> <li>Statics</li> <li>Running Boar</li> </ol> </li> <li>Melville</li> <li>Stickledown</li> <li>Pirbright</li> </ol> </li> <li><b>Access:</b> <ol style="list-style-type: none"> <li>All movement forward of the Running Boar Range firing point requires the following ranges to have ceased fire: <ol style="list-style-type: none"> <li>Running Deer</li> <li>Statics</li> <li>Running Boar</li> </ol> </li> <li>When there are personnel forward of the firing points, the red flag system is to be followed under the direction of the BSR Manager</li> <li>When shooting is conducted from the turning target firing</li> </ol> </li> </ol>

	<p>points, the BSR Manager is to ensure demarcation lines are set up between Running Deer and Statics range to ensure safe access/egress</p> <ol style="list-style-type: none"> <li>3. Another shooter is permitted to dry fire from the alternate lane for the moving target</li> <li>4. Range infrastructure is not to be used as targetry or to zero/check zero firearms</li> <li>5. A Suitably Qualified Experience Person (SQEP) is to be appointed as the responsible RO when shooting</li> <li>6. Vehicles are not permitted on the range floor without prior permission from the BSR manager</li> </ol>
<b>Firing positions</b>	<ol style="list-style-type: none"> <li>7. <b>Positions permitted:</b> <ol style="list-style-type: none"> <li>a. Benched</li> <li>b. Standing</li> <li>c. ISSF start position only for those who have passed Deer Competency</li> <li>d. Kneeling</li> <li>e. Sitting</li> </ol> </li> <li>8. Permission to fire from any other position (such as obstacles) is to be approved by the BSR manager. Obstacles are to be provided by BSR.</li> <li>9. Changes of position are permitted within any detail or practice outside competition providing all firers follow the same sequence, and in competition in accordance with the conditions</li> </ol>
<b>Targetry</b>	<ol style="list-style-type: none"> <li>10. <b>MAX TCH:</b> 1.5m</li> <li>11. Only targets from the BSR approved set may be used</li> <li>12. Targets are to be used in the frames or holders provided and are to be engaged only from the recognised firing points and/or appropriate shooting station or peg. Any deviation from this is to be notified and approved by the NSC Head of Operations.</li> <li>13. Moving Target is to be engaged from a maximum of 100m. Any reduction in the engagement distance must be requested and approved by the NSC Head of Operations.</li> <li>14. Falling Plates or other hard targets may not be engaged within Running Deer Range</li> </ol>
<b>ACCIDENT/INCIDENT PROCEDURES</b>	
<b>Special Safety Instructions</b>	As per the NRA Range Action Safety Plan which will be initiated by the Range Office on notification of a major incident/accident
