## **NATIONAL SHOOTING CENTRE (NSC) BISLEY**

### **FIREARM / EQUIPMENT HIRE - TERMS AND CONDITIONS**

#### **LOCATION**

1. All NSC hire firearms are stored within the Armoury.

#### **ELIGIBLE PERSONS**

2. Firearms and equipment are available for hire only to:
  - a. Full NRA members in possession of a valid Shooter Certification Card (SCC) for the relevant discipline.
  - b. Members of a Home Office Approved or affiliated club, authorised by their Club Chairman, who hold a valid SCC for the relevant discipline.
3. Firearms will not be issued under the authority of a Club Firearm Certificate (FAC).

#### **BOOKING PROCEDURE**

4. All hire requests must be submitted via email to **NRA.armoury@nra.org.uk** at least two working days prior to the event.
5. Requests must include:
  - a. Membership number
  - b. Club affiliation number (where applicable)
  - c. Full name
  - d. Date of hire
  - e. Specific firearm / equipment request
  - f. Period of hire (AM/PM/All Day)
6. Hire requests are subject to availability.
7. A booking is considered confirmed once acknowledged by the Armoury. By confirming a booking (including via email), the hirer agrees to be legally bound by these Terms and Conditions and accepts liability for all applicable charges, including those arising from late cancellation or non-attendance. Where a booking is made on behalf of a club, the individual making the booking warrants that they are authorised to do so, and the club and the individual hirer shall be jointly and severally liable for all charges.

#### **COLLECTION AND USE**

8. On the day of hire, all users must present a valid SCC and NRA Membership/Affiliated Club Membership card.

9. All firearms will have undergone a pre-use inspection by the Armoury and will be issued in a safe and serviceable condition.

## **RETURN REQUIREMENTS**

10. Upon return of the firearm and/or equipment, the user must:

- a. Provide a record of rounds fired, and
- b. Report any faults, defects or damage.

11. All firearms and equipment (including magazines and DOPE cards) must be returned to the NRA Armoury no later than 15 minutes after the end of the shooting period.

13. Availability must be confirmed directly with the Armoury via email.

## **HIRE CHARGES**

14. Hire charges are published annually and are available on the NSC website.

## **USE RESTRICTIONS**

15. NSC firearms & equipment may only be used on NSC ranges at Bisley and must not be removed from the site under any circumstances.

- a. Firearms hired for use on Chobham Ridge Range must be transported by an authorised servant of the NRA Registered Firearms Dealer (RFD).

16. Only factory-loaded ammunition may be used. The use of home-loaded ammunition is strictly prohibited.

17. Users must not make any mechanical alterations to firearms, optics, or associated equipment. Adjustments to scope elevation and windage are permitted. Guidance can be provided at the time of hire if required.

## **LIABILITY AND RESPONSIBILITY**

18. The hirer is responsible for the firearm/equipment from the point of issue until it is returned to the Armoury.

19. The hirer is liable for any loss or damage arising during this period

20. Any damage or missing components identified by the duty Armourer and attributed to misuse or negligence will be charged to the individual or club hiring the firearm/equipment. Such costs are not covered by NRA insurance.

## **PAYMENT**



21. Payment is due no later than the day of hire. Where payment has not been made or where charges arise from late cancellation or non-attendance, the NRA reserves the right to issue an invoice after the booking date, payable in accordance with the stated invoice terms.

### **CANCELLATIONS AND NON-ATTENDANCE**

22. Cancellations made within 48 hours of the hire date, or failure to collect the firearm/equipment, will incur the full hire charge, which shall be payable in full regardless of whether the hire is collected or used.

23. Where payment has not been made, the NSC reserves the right to invoice for the full hire charge.

### **OUTSTANDING PAYMENTS**

24. Failure to settle outstanding charges will result in suspension of NRA account privileges and may include restriction of future bookings until the charges are cleared.

25. The NRA reserves the right to issue invoices for any outstanding charges, including late cancellations, non-attendance, damage or loss. Payment must be made in accordance with the stated invoice terms.

### **RIGHT OF REFUSAL**

26. The NSC reserves the right to refuse access to firearms, ammunition or equipment at its discretion.

27. The NSC also reserves the right to refuse future bookings where there is a history of late cancellation, non-attendance, or unpaid charges.
